# Introduction to the 10 Principles of Fairtrade Bible Study Guide

This Bible study guide is designed for UK-based churches and followers of Jesus Christ to explore the Fairtrade movement through a biblical lens. By reflecting on how we consume products, engage with business practices, and trade globally, we seek to align these choices with the teachings of Jesus.

Fair Trade is defined as "a trading partnership, based on dialogue, transparency, and respect that seeks greater equity in international trade." This movement prioritises people and the planet over profit, promoting sustainable development and justice for the most marginalised producers, especially those in the Global South.



As you work through this guide, take time to reflect on each principle and its biblical connections. We recommend using the W-R-A-P method:

• **Word**: Read the scriptures and consider how they connect with the Fairtrade principle.

• **Reflection**: How has your thinking or perspective changed after reading these scriptures?

• **Action**: What practical steps can you take in response to this study?

• **Prayer**: Compose a prayer that draws on the principle, the scriptures, and your reflections.

Before beginning each session, offer thanks to God for the Earth and its resources, and reflect on the historic and ongoing stewardship of the land, especially remembering the diverse communities in the UK and their contributions to social and economic justice.

#### What Does the Bible Say?

It is tempting to use scripture out of context to justify nearly any action. For example, a profit-driven entrepreneur could point to James 4:13, which says, "Come now, you who say, 'Today or tomorrow we will go to such and such a town and spend a year there, doing business and making money," as a scriptural backing for pursuing wealth. However, this is not a reflection of the broader biblical narrative on justice, mercy, or ethical business practices.

We've all encountered moments when a passage of scripture leaves us scratching our heads. Have you ever wondered, "What is this verse trying to tell me?" Or questioned how the God described in the Old Testament aligns with the God revealed through Jesus Christ? Moreover, how does scripture, written over thousands of years, fit into our modern context, particularly in light of science and societal change? The astonishing thing about the Bible isn't that parts of it are challenging to interpret; rather, it's remarkable that it speaks so clearly to our lives across centuries. For example, slavery is mentioned in various parts of the Bible as a norm in society. But it was the evangelical Christian movement in the 19th century that spearheaded the abolition of slavery, recognising that this practice contradicted the core biblical message of love and justice.

#### Studying the Bible Through the Lens of Fairtrade

The purpose of these studies is to explore the relationship between the Bible and the 10 Principles of Fairtrade. The goal is not to force scripture to fit these principles but to reflect on how biblical teachings align with the values of justice, transparency, and care for the marginalised, which underpin Fairtrade.

When studying the Bible, context is key. Each book was written in a specific time, for a specific people, with cultural norms and understandings that may differ vastly from ours. Whether we are reading Numbers or Revelation, we must consider how these words, written thousands of years ago, still carry relevance in today's world.

The approach taken in these studies is thematic, guided by the principles of Fairtrade. Where we begin with the Bible often reflects where we find ourselves on the Christian spectrum—whether we lean more towards Fundamentalism, Evangelicalism, or a more Progressive or Liberal approach to faith. However, these studies do not seek to endorse a specific theological stance. Instead, the Bible is viewed as a witness to the living Word, Jesus Christ, whose teachings on justice, love, and mercy are central to our understanding of Fairtrade.

#### The Foundation of These Studies: Love (Agape)

The biblical principle that runs through these studies is agape the selfless, sacrificial love that is central to the Christian faith.

- **First**, there is the love that God has for all creation, expressed most clearly in John 3:16: "For God so loved the world (cosmos) that he gave his one and only Son...". This is the foundation upon which our call to justice is built.
- **Second**, is our response to God's love. When Jesus was asked about the greatest commandment, He answered: "Love the Lord your God with all your heart and with all your soul and with all your mind... And love your neighbour as yourself" (Matthew 22:34-40, Mark 12:28-34, Luke 10:25-28).

Jesus further expounded on what it means to love our neighbour in the parable of the Good Samaritan, where He challenges us to care for those in need, regardless of societal divisions. This principle of love is foundational to all ten Fairtrade principles—each rooted in the idea of love for God, love for neighbour, and love for creation.

In essence, these Bible studies are designed to encourage reflection on how we live out our faith through actions that reflect justice, love, and mercy. The principles of Fairtrade offer a practical framework for this, as they align with biblical teachings that call us to care for the vulnerable, treat others fairly, and act as stewards of God's creation.

# Bible Lesson 1: Principle 1 – Opportunities for Disadvantaged Producers

**Fair Trade Principle**: Fairtrade organisations work to reduce poverty by providing disadvantaged producers with opportunities to become self-sufficient. These producers may be small farmers, artisans, or cooperatives struggling to secure a stable income. As we approach this study, let's use the WRAP method to guide us. We will read the Word, reflect on how it applies to Fairtrade principles, consider actions we can take, and close with a prayer for justice.

#### Scriptures to Study:

- **1 Kings 21** Naboth's Vineyard: A story of injustice and abuse of power where the vulnerable are exploited.
- **Micah 6:6-8** What does the Lord require? To act justly, love mercy, and walk humbly with God.
- Luke 1:46-55 The Magnificat: Mary's song of praise for a God who uplifts the poor and brings justice to the oppressed.

**Reflection**: Consider how your shopping choices may impact the most vulnerable. Are you supporting businesses that exploit disadvantaged producers, or are you contributing to their self-sufficiency through Fairtrade? How can your faith in a just God influence the way you engage with global trade?

**Action**: Commit to purchasing Fairtrade goods as much as possible. Advocate for Fair Trade products in your local church, community groups, or workplace.

**Prayer**: Loving God, we give thanks for the opportunities that Fairtrade provides to those living in poverty. Help us to live justly, reflecting Your love for the vulnerable through our choices. Teach us to lift others up as You lift us. Amen.

Sermon 1: Opportunities for Disadvantaged Producers – A Call to Justice and Mercy

#### Scriptures:

- 1 Kings 21 (Naboth's Vineyard)
- Micah 6:6-8
- Luke 1:46-55 (The Magnificat)

#### Introduction:

Good morning, Church. Today, we begin with **Principle 1 of Fairtrade – Opportunities for Disadvantaged Producers**. This principle is about providing opportunities for small farmers, artisans, and cooperatives who struggle to make a stable income. Fairtrade organisations work to **reduce poverty** by creating opportunities for these producers to become self-sufficient, ensuring they can live with dignity and support their families.

As Christians, we are called to reflect God's justice, mercy, and love in all that we do, including the way we engage with the global economy. Today, we will explore what the Bible says about justice for the poor and vulnerable, and how we can align our choices with God's desire to uplift and empower those who are often exploited.

#### 1 Kings 21 – Naboth's Vineyard: A Story of Injustice

In 1 Kings 21, we find the story of Naboth's vineyard, a powerful account of **injustice and abuse of power**. Naboth owned a vineyard that King Ahab coveted. When Naboth refused to sell it because it was his family's inheritance, Queen Jezebel devised a plot to falsely accuse him and have him executed so Ahab could take the land.

"So they took Naboth outside the city and stoned him to death... As soon as Jezebel heard that Naboth had been stoned to death, she said to Ahab, 'Get up and take possession of the vineyard of Naboth the Jezreelite that he refused to sell you." (1 Kings 21:13-15)

This is a tragic story of **exploitation** and injustice. Naboth, a vulnerable man simply trying to hold on to his inheritance, was crushed by the greed of the powerful. His land was taken from him, and his life was lost.

In many ways, this story reflects the exploitation of small farmers and producers in today's world. Large corporations often **exploit the vulnerable**, paying them unfair wages, taking their land, or forcing them into unjust trade practices. But just as God was angered by the injustice done to Naboth, He is angered by the exploitation of the poor and vulnerable today.

Fairtrade provides an alternative to this exploitation. It creates opportunities for small producers to sell their goods at a fair price, allowing them to sustain their livelihoods and avoid the fate of Naboth. As Christians, we are called to **stand against exploitation** and support systems that uphold justice and fairness.

#### Micah 6:6-8 – What Does the Lord Require?

In Micah 6:6-8, the prophet Micah asks the people of Israel what kind of worship truly pleases God. The answer is clear:

"He has shown you, O mortal, what is good. And what does the Lord require of you? To act justly and to love mercy and to walk humbly with your God."

God does not desire empty rituals or sacrifices. What He desires is for us to **act justly**, to love mercy, and to walk humbly with Him. This call to justice and mercy is central to how we should live our lives, including how we engage with global trade.

In today's world, **acting justly** means supporting systems that treat workers fairly and ensure that producers receive a fair price for their goods. It means avoiding companies and products that exploit vulnerable workers for profit. Fairtrade aligns with this call to justice by ensuring that farmers, artisans, and other producers are paid fairly for their work, allowing them to live with dignity.

**Loving mercy** means caring for the vulnerable and disadvantaged, just as God cares for them. By purchasing Fairtrade goods, we are showing mercy to those who are often overlooked and exploited in the global economy.

#### Luke 1:46-55 – The Magnificat: God Uplifts the Poor

The **Magnificat**, Mary's song of praise in Luke 1:46-55, is a beautiful proclamation of God's heart for the poor and oppressed. Mary declares:

"He has brought down rulers from their thrones but has lifted up the humble. He has filled the hungry with good things but has sent the rich away empty." (Luke 1:52-53)

In this passage, Mary celebrates a God who **lifts up the poor** and **brings justice** to the oppressed. This is a God who cares deeply about the plight of the vulnerable and who works to bring about justice for those who are marginalized.

Fairtrade embodies this same vision of justice. It seeks to **uplift the poor** by providing them with opportunities to sell their goods at a fair price, breaking the cycle of poverty and exploitation. When we support Fairtrade, we are participating in God's work of **lifting up the humble** and ensuring that the vulnerable are treated with dignity.

#### **Reflection: How Do Your Choices Impact the Most Vulnerable?**

As we reflect on these scriptures, we are reminded that **unjust practices**—whether in ancient Israel or in today's global economy—are condemned by God. He calls us to **act justly, love mercy, and walk humbly** with Him. But what does this look like in our everyday lives?

Each time we purchase a product, we are making a choice that impacts someone else's life. If we support businesses that exploit workers and pay unfair wages, we are complicit in that exploitation. But if we choose to support Fairtrade products, we are contributing to the **self-sufficiency** of small producers, ensuring that they are paid fairly for their labour and can support their families.

So, how can your faith in a just God influence the way you engage with global trade? How can you make choices that reflect God's heart for justice, mercy, and fairness?

#### Action: Commit to Supporting Fairtrade

I want to encourage all of us to take **practical steps** in response to today's lesson. Let's commit to purchasing Fairtrade goods whenever possible. This may mean looking for the Fairtrade label on products like coffee, tea, chocolate, and clothing. By choosing Fairtrade, we are supporting farmers and workers who are paid fairly for their labour and are given the opportunity to improve their lives.

Let's also advocate for Fairtrade in our local communities, workplaces, and churches. Encourage your church to use Fairtrade products in events and services. Organise discussions or awareness campaigns to help others understand the importance of fair trade and ethical consumption. Together, we can make a difference by ensuring that **the most vulnerable are treated with dignity**.

#### Prayer:

Let us pray.

#### Loving God,

We give thanks for the opportunities that Fairtrade provides to those living in poverty. We thank You for the chance to participate in Your work of justice, lifting up the vulnerable and treating all people with dignity. Help us to live justly, reflecting Your love for the poor and oppressed through our choices. Teach us to lift others up as You lift us, and guide us to be agents of Your justice in the world. In Jesus' name, we pray. **Amen**.

#### **Conclusion:**

As we leave today, let us remember that God's call to justice is not just about what happens in church—it's about how we live our daily lives. By supporting Fairtrade, we can ensure that the choices we make reflect God's heart for the poor and vulnerable. Let us commit to making fair and just choices in the products we buy and to **advocating for justice in our communities**. **Amen.** 

# Bible Lesson 2: Principle 2 – Transparency & Accountability

**Fairtrade Principle**: Fairtrade organisations operate with transparency and involve stakeholders, employees, and producers in decision-making processes. As we approach this study, let's use the WRAP method to guide us. We will read the Word, reflect on how it applies to Fairtrade principles, consider actions we can take, and close with a prayer for justice.

#### Scriptures to Study:

- **Ruth 4** Boaz's redemption of Ruth through transparent actions in front of the community.
- Luke 12:42-48 The parable of the faithful and unfaithful servant, highlighting the importance of doing right and being held accountable.
- **Psalm 72** A prayer for a just king to lead with fairness and transparency.

**Reflection**: Transparency is a cornerstone of trust. Fairtrade organisations ensure transparency in every step, from sourcing to the final product. How can your faith communities demand transparency and fairness from the companies you support? How does this align with God's desire for justice and honesty?

**Action**: Research the supply chains of the products you use regularly. Encourage your church or community to promote ethical and transparent businesses.

## Sermon 2: Transparency and Accountability – Building Trust in Trade and Faith

#### Scriptures:

- Ruth 4
- Luke 12:42-48
- Psalm 72

#### Introduction:

Good morning, Church. Today, we reflect on **Principle 2 of Fairtrade – Transparency and Accountability**. Fairtrade organisations ensure that transparency and accountability are at the heart of their operations, from the way products are sourced to how decisions are made. This principle is critical for building trust between producers, consumers, and businesses.

As followers of Christ, we know that **transparency and accountability** are also fundamental to how we are called to live. In scripture, we are reminded time and again that God desires honesty, fairness, and integrity from His people, whether in business, leadership, or personal relationships. Today, we will look at how these biblical principles can guide us to promote fairness and transparency in trade, while also reflecting God's justice in our everyday lives.

#### Ruth 4 – Boaz's Transparent Redemption of Ruth

In Ruth 4, we find a beautiful example of transparency and accountability in action. After Ruth and Boaz meet and develop a bond, Boaz goes to the city gate to **redeem Ruth** according to the customs of the time. Boaz doesn't act secretly or behind closed doors. Instead, he calls together the elders and the community to witness his actions and ensure that everything is done properly and openly:

"Then Boaz said to the elders and all the people, 'Today you are witnesses that I have bought from Naomi all the property of Elimelek, Kilion and Mahlon. I have also acquired Ruth the Moabite, Mahlon's widow, as my wife, in order to maintain the name of the dead with his property, so that his name will not disappear from among his family or from his hometown. Today you are witnesses!"" (Ruth 4:9-10)

Boaz's actions were completely transparent. He made sure that the entire community was involved in the decision-making process, leaving no room for confusion or doubt. His transparency built trust and demonstrated his commitment to doing what was right in the eyes of the community and in the sight of God.

This same principle of **transparency in action** is central to Fairtrade practices. Fairtrade organisations ensure that everyone involved in the supply chain, from producers to consumers, knows what is happening at every step. Decisions are made openly, and stakeholders have a voice in the process. As consumers, we should demand this same level of transparency in the products we buy and the companies we support.

#### Luke 12:42-48 – The Parable of the Faithful and Unfaithful Servant

In Luke 12:42-48, Jesus tells the parable of the faithful and unfaithful servant, teaching us the importance of doing what is right, even when no one is watching: "The Lord answered, 'Who then is the faithful and wise manager, whom the master puts in charge of his servants to give them their food allowance at the proper time? It will be good for that servant whom the master finds doing so when he returns."

The faithful servant is one who carries out his duties with integrity, ensuring that the people under his care are treated fairly and given what they need. In contrast, the unfaithful servant abuses his power, thinking that no one will notice or hold him accountable.

This parable speaks directly to the heart of **accountability**. God expects us to act with fairness and responsibility, knowing that we will be held accountable for our actions. In the same way, businesses, organisations, and leaders are accountable for how they treat their workers, customers, and stakeholders. Fairtrade organisations strive to hold businesses accountable for their actions, ensuring that **justice is done** and that workers are treated fairly and transparently.

As Christians, we are called to hold ourselves and the companies we support to the same standard of **integrity and accountability**. Just as the faithful servant was responsible for ensuring fairness in his dealings, we must demand that the businesses we engage with operate with transparency and uphold the dignity of their workers.

#### Psalm 72 – A Prayer for a Just and Transparent King

Psalm 72 is a prayer for a king who will rule with justice and fairness. The psalmist prays for a king who will defend the cause of the poor and **lead with transparency and righteousness**:

"Endow the king with your justice, O God, the royal son with your righteousness. May he judge your people in righteousness, your afflicted ones with justice... For he will deliver the needy who cry out, the afflicted who have no one to help." (Psalm 72:1-2, 12)

This psalm reminds us that **just leadership** is marked by fairness, transparency, and care for the vulnerable. God's desire for leaders, both in government and in business, is that they rule with integrity and ensure that justice is done for all, especially those who are most vulnerable.

Fairtrade organisations embody this principle by ensuring that workers, especially those in disadvantaged communities, are treated fairly. They involve stakeholders at every level, making decisions in an open and transparent manner. As people of faith, we are called to support such practices and to pray for leaders who will **lead with justice, transparency, and compassion**.

#### **Reflection: Transparency and Accountability in Our Lives**

Transparency is the **cornerstone of trust**, and without it, we cannot build just systems. Fairtrade ensures transparency in every step of the supply chain, from sourcing to the final product. But how can we, as individuals and as faith communities, demand the same level of transparency and fairness from the companies we support?

First, we must be informed. **Do we know where our products come from?** Are the companies we buy from transparent about their sourcing, production, and labour practices? We should seek to understand the supply chains of the products we use regularly and support businesses that prioritise transparency and accountability.

Second, we should be advocates for **fair and ethical business practices**. This can mean raising awareness in our communities, encouraging others to buy from transparent and ethical companies, and holding businesses accountable for how they treat workers and produce their goods.

Finally, transparency begins with us. We are called to be **transparent and accountable in our own lives**, in our dealings with others, and in the decisions we make. When we live with integrity, we reflect God's justice and truth in the world.

#### Action: Research and Promote Transparency

Let's take action today by committing to **research the supply chains** of the products we use regularly. Look into how the companies you support operate—are they transparent about their practices? Do they treat workers fairly?

Encourage your church or community to promote **ethical and transparent businesses**. Whether through discussions, educational events, or simply sharing information, we can help others understand the importance of supporting companies that prioritise fairness and justice.

#### Prayer:

Let us pray.

#### Gracious God,

We thank You for the example of transparency and accountability set before us in Your Word. Help us to demand fairness and openness in all our dealings, whether in business, trade, or community life. May we reflect Your integrity and justice in all that we do, ensuring that we act with honesty and transparency in our own lives. Give us the courage to stand for what is right and to promote fairness and accountability in the world around us.

In Jesus' name, we pray. Amen.

#### **Conclusion:**

As we leave here today, let us remember that **God calls us to transparency and accountability**. Whether we are engaging in business, leading others, or making daily decisions, we are called to act with fairness, honesty, and integrity. #### **Bible Lesson 3: Principle 3 – Fairtrade Practices**

**Fairtrade Principle**: Fairtrade organisations prioritise people and the environment over profits, ensuring that trade practices are fair and sustainable. As we approach this study, let's use the WRAP method to guide us. We will read the Word, reflect on how it applies to Fairtrade principles, consider actions we can take, and close with a prayer for justice.

#### Scriptures to Study:

- **Amos 2:6-8** God's judgement against Israel for unjust trade and exploitation of the poor.
- John 2:13-22 Jesus drives the money changers out of the temple, protesting against the exploitation of worshippers through unfair trade.
- Luke 4:14-21 Jesus' manifesto of justice: proclaiming good news to the poor and freedom for the oppressed.

**Reflection**: Unjust practices are condemned throughout the Bible. The Fairtrade movement offers an alternative, ensuring that producers are treated with dignity. How can you support these efforts in your everyday life? Are there unjust practices you need to challenge in your own community?

**Action**: Get involved in campaigns for fair trade and ethical sourcing in your local area. Speak up when you see injustice, whether it's in business, trade, or community dealings.

**Prayer**: God of Justice, we pray for the courage to stand against unjust practices in trade and business. Help us to be advocates for those who are marginalised and exploited, and to reflect Your love in our actions. Amen.

#### Sermon: Fairtrade Practices – Putting People and the Planet Over Profit

#### Scriptures:

- Amos 2:6-8
- John 2:13-22
- Luke 4:14-21

#### Introduction:

Good morning, Church. Today we will explore **Principle 3 of Fairtrade – Fairtrade Practices**. This principle prioritises people and the environment over profits, ensuring that trade practices are fair and sustainable. Fairtrade promotes an economic system where workers and producers are treated with dignity, where the environment is protected, and where justice is at the core of business practices.

The Bible repeatedly condemns unjust practices, particularly those that exploit the poor and the vulnerable. We will look at how scripture calls us to engage in **just practices** in business, trade, and community life. Together, we'll reflect on how the Fairtrade movement offers us a way to live out these biblical values, ensuring that people and creation are valued over profit.

#### Amos 2:6-8 – God's Judgment on Unjust Trade

In Amos 2:6-8, God speaks through the prophet Amos to deliver a harsh judgment on the people of Israel:

"This is what the Lord says: 'For three sins of Israel, even for four, I will not relent. They sell the innocent for silver, and the needy for a pair of sandals. They trample on the heads of the poor as on the dust of the ground and deny justice to the oppressed."

In this passage, Israel is condemned for **exploiting the poor** and engaging in unjust trade practices. They were selling the needy for mere silver, ignoring the humanity of those who were suffering. Their desire for profit was more important to them than justice, and they trampled on the heads of the vulnerable to get ahead.

This is a sobering message for us today. We live in a world where, far too often, the poor are exploited for the sake of profit. Large corporations cut corners, exploit workers, and degrade the environment in the pursuit of wealth. But just as God condemned Israel for these injustices, He calls us to live by a different standard—**a** standard of justice, fairness, and compassion.

The Fairtrade movement offers us an alternative. It provides a model where **workers are paid fairly**, the environment is protected, and businesses are held accountable for their impact on both people and planet. It challenges the idea that profit is the only measure of success and insists that justice and sustainability must come first.

#### John 2:13-22 – Jesus Drives the Money Changers from the Temple

In John 2:13-22, we see one of the most dramatic moments in Jesus' ministry—His confrontation with the **money changers in the temple**:

"When it was almost time for the Jewish Passover, Jesus went up to Jerusalem. In the temple courts he found people selling cattle, sheep and doves, and others sitting at tables exchanging money. So he made a whip out of cords, and drove all from the temple courts... He scattered the coins of the money changers and overturned their tables."

Jesus was outraged because the temple, a place of worship and communion with God, had been turned into a marketplace where worshippers were exploited. The money changers were using their position to **unfairly profit** from those who came to the temple to worship, taking advantage of their vulnerability.

This story reminds us that **unjust trade practices**—those that exploit the vulnerable for profit—are deeply offensive to God. Jesus' actions demonstrate that **God cares about justice in all areas of life**, including the way we conduct business. When trade and commerce become a means of exploitation, rather than service to others, it is a violation of God's will.

Fairtrade aligns with this biblical vision of justice by ensuring that workers and producers are treated fairly. It rejects the exploitation of people for profit and seeks to create a system where trade is just and beneficial for all involved. As followers of Christ, we are called to **stand against unfair practices** in trade and business, just as Jesus did.

#### Luke 4:14-21 – Jesus' Manifesto of Justice

In Luke 4:14-21, Jesus begins His public ministry by reading from the book of Isaiah: "The Spirit of the Lord is on me, because he has anointed me to proclaim good news to the poor. He has sent me to proclaim freedom for the prisoners and recovery of sight for the blind, to set the oppressed free, to proclaim the year of the Lord's favour."

This is Jesus' **manifesto of justice**. He declares that His mission is to bring good news to the poor, to free the oppressed, and to bring healing and wholeness to the world. Jesus came to establish a Kingdom where justice reigns, where the needs of the vulnerable are met, and where **oppression is no longer tolerated**.

This mission is directly connected to the work of Fairtrade. Fairtrade seeks to **proclaim good news to the poor** by ensuring that farmers, workers, and producers are paid fairly for their work. It aims to **set the oppressed free** by rejecting systems of exploitation and promoting economic justice. By supporting Fairtrade, we are participating in the work of **Christ's Kingdom**, working to create a world where justice and dignity are at the heart of trade and business.

#### **Reflection: Challenging Unjust Practices**

The Bible consistently condemns unjust practices that exploit the poor, and it calls us to engage in **fair and ethical trade**. But how do we put this into action in our everyday lives? How can we challenge unjust practices in our own communities and in the wider world?

First, we need to **educate ourselves**. It's important to understand where the products we buy come from, how they are made, and who benefits from our purchases. #### Sermon 4: Fair Payment – A Biblical Mandate for Justice

#### Introduction:

Good morning, Church. Today, we are going to reflect on **Principle 4 of Fairtrade – Fair Payment**. This principle ensures that producers and workers receive a fair wage for their labour, allowing them to live with dignity and support their families. The Bible has much to say about justice and fair wages, calling us to be advocates for those who work hard but are often exploited or underpaid.

The scriptures we will explore today remind us that **fair wages are not just an economic issue but a moral and spiritual one**. #### Isaiah 58:1-12 – A Call to True Fasting and Justice

In Isaiah 58:1-12, God speaks through the prophet Isaiah to call His people back to **true worship and justice**. The people of Israel were fasting and offering prayers, but their worship was hollow because they were neglecting justice and oppressing their workers:

"Is not this the kind of fasting I have chosen: to loose the chains of injustice and untie the cords of the yoke, to set the oppressed free and break every yoke?... If you do away with the yoke of oppression, with the pointing finger and malicious talk, and if you spend yourselves in behalf of the hungry and satisfy the needs of the oppressed, then your light will rise in the darkness, and your night will become like the noonday." (Isaiah 58:6, 9-10)

God makes it clear that **true fasting**—true worship—includes acts of justice. This involves breaking the chains of oppression, ensuring fair treatment of workers, and advocating for those who are vulnerable. Fair wages are a key part of this. When workers are paid fairly, they are able to support their families, live with dignity, and avoid exploitation.

This passage challenges us to reflect on how we treat those who work to produce the goods we consume. Are the people who make our clothes, grow our food, and produce our products paid fairly? Are they treated with dignity, or are they oppressed by unfair wages? God calls us to take these questions seriously as part of our worship and discipleship.

#### Matthew 20:1-16 – A Fair Day's Pay for a Fair Day's Work

In Matthew 20:1-16, Jesus tells the **Parable of the Labourers in the Vineyard**, which offers a profound reflection on the fairness of wages:

"For the kingdom of heaven is like a landowner who went out early in the morning to hire workers for his vineyard. He agreed to pay them a denarius for the day and sent them into his vineyard."

As the day goes on, the landowner continues to hire more workers, some as late as the last hour of the day. At the end of the day, all the workers, regardless of when they started, are paid the same wage—a full day's pay. Naturally, those who worked all day are frustrated, feeling that they deserved more than those who worked only a short time. But the landowner replies:

"Friend, I am not being unfair to you. Didn't you agree to work for a denarius?... I want to give the one who was hired last the same as I gave you. Don't I have the right to do what I want with my own money? Or are you envious because I am generous?" (Matthew 20:13-15)

This parable teaches us about **God's generosity and fairness**. The landowner paid all the workers a fair wage, ensuring that even those who worked only a short time could live and support their families. It also reminds us that **fairness in wages is not about rewarding people based on how much they can produce**, but about ensuring that everyone receives what they need to live.

In our world today, many workers, especially in developing countries, work long hours under harsh conditions and receive wages that are far below what they need to survive. The Fairtrade movement ensures that workers receive a living wage—a wage that allows them to live with dignity, care for their families, and plan for the future. As followers of Christ, we are called to support this kind of fairness in the marketplace.

#### James 5:1-6 – Warnings Against Withholding Fair Wages

James 5:1-6 offers a stern warning to those who exploit their workers and withhold fair wages:

"Look! The wages you failed to pay the workers who mowed your fields are crying out against you. The cries of the harvesters have reached the ears of the Lord Almighty. You have lived on earth in luxury and self-indulgence. You have fattened yourselves in the day of slaughter."

James condemns those who grow rich by **exploiting their workers**—those who withhold wages, cheat their employees, and build their wealth on the backs of the

poor. He warns that the cries of the oppressed have reached God's ears, and judgment is coming for those who perpetuate injustice.

This is a powerful reminder that God takes **fair wages seriously**. The way we treat workers—whether we pay them fairly or exploit them for profit—matters to God. When companies withhold fair wages, they are not just committing an economic injustice; they are violating a principle that is central to God's heart.

As consumers, we have a responsibility to ensure that the products we buy are made by workers who are paid fairly. By supporting Fairtrade, we can help ensure that the people who produce the goods we enjoy are treated with dignity and receive the wages they deserve.

#### **Reflection: Promoting Fair Wages**

### Sermon 5: No Child Labour, No Forced Labour – Defending the Dignity of All Workers

#### Introduction:

Good morning, today, we reflect on **Principle 5 of Fairtrade**: the prohibition of **child labour and forced labour**. This principle ensures that producers uphold the dignity and rights of all workers, particularly the most vulnerable children. Yet, today, millions of children are trapped in labour that robs them of their childhood, education, and future. Children work in mines, fields, and factories under harsh and dangerous conditions, often to produce goods that end up on our shelves.

When we choose to support industries that exploit children, we are complicit in causing these "little ones" to stumble. But Jesus calls us to do the opposite—to welcome, protect, and honour children. This is a direct challenge to the systems of

exploitation that profit from child labour. As Christians, we must ask ourselves: are we contributing to these injustices, or are we standing with Jesus in defence of the vulnerable?

#### Exodus 2:23-3:12 – God Hears the Cries of the Oppressed

The story of the Israelites' slavery in Egypt is one of the most profound examples of oppression in the Bible. In Exodus 2:23-3:12, we read how the Israelites, trapped in forced labour, cried out to God in their suffering:

"The Israelites groaned in their slavery and cried out, and their cry for help because of their slavery went up to God. God heard their groaning, and He remembered His covenant with Abraham, with Isaac, and with Jacob."

God hears the cries of the oppressed and responds with action. He calls Moses to deliver the Israelites from their bondage and leads them out of slavery with great signs and wonders. This is the heart of God—He hears the cries of those who are suffering under oppression and acts to bring about their freedom.

## Sermon 7: Good Working Conditions – Reflecting God's Justice and Care

#### Scriptures:

- Exodus 1:8-14
- Ephesians 6:5-9
- Psalm 146

#### Introduction:

Good morning, Church. Today, we turn our attention to **Principle 7 of Fairtrade – Good Working Conditions**. Fairtrade ensures that workers around the world are provided with safe and healthy working environments. But this is not just a modern concern—it's a principle deeply rooted in our Christian faith.

God calls us to care for one another, to protect the vulnerable, and to ensure that justice is done. How we treat workers—those who labour in factories, fields, and workshops—is a reflection of our relationship with God and our understanding of His justice.

In this sermon, we will explore what the Bible says about working conditions, how God cares for those who are oppressed, and how we, as a church, can advocate for fair treatment in the workplace.

### Exodus 1:8-14 – The Israelites' Suffering Under Oppressive Working Conditions

The story of the Israelites in Egypt is one of the most vivid examples in the Bible of people suffering under **oppressive working conditions**. In Exodus 1:8-14, we read that a new Pharaoh came to power in Egypt, one who did not know Joseph. Out of fear of the growing Hebrew population, Pharaoh subjected the Israelites to forced labour:

"So they put slave masters over them to oppress them with forced labour, and they built Pithom and Rameses as store cities for Pharaoh... They made their lives bitter with harsh labour in brick and mortar and with all kinds of work in the fields; in all their harsh labour the Egyptians worked them ruthlessly."

This passage paints a grim picture of exploitation and suffering. The Israelites were forced to work under brutal conditions, with no regard for their dignity, health, or wellbeing. Their labour was seen as a means to build wealth and power for Pharaoh, with little concern for their humanity.

Sadly, this story is not just an ancient one. Today, there are still millions of people around the world who work in harsh, unsafe, and unjust conditions—whether it's in

sweatshops, factories, or fields. Many of the products we buy are made by workers who are denied fair wages and forced to endure unsafe environments.

As Christians, we cannot turn a blind eye to this injustice. The story of the Israelites reminds us that God hears the cries of the oppressed and that He calls us to do something about it.

#### Ephesians 6:5-9 – Guidelines for Workers and Employers

In Ephesians 6:5-9, Paul gives guidelines for relationships between workers and employers:

"Slaves, obey your earthly masters with respect and fear, and with sincerity of heart, just as you would obey Christ... And masters, treat your slaves in the same way. Do not threaten them, since you know that He who is both their Master and yours is in heaven, and there is no favouritism with Him."

Although this passage was written in a context where slavery was a part of the social structure, its principles still apply to our modern relationships between employers and employees. Paul is calling for **mutual respect**—workers are to work with integrity, and employers are to treat their workers fairly and with dignity.

In today's world, this means ensuring that workers have safe, healthy, and respectful working environments. It means providing fair wages, avoiding exploitation, and recognising the humanity of each worker. Paul reminds us that God shows no favouritism—whether we are employees or employers, we are all accountable to God for how we treat one another.

Fairtrade upholds this biblical principle by ensuring that workers are treated with respect, paid fairly, and provided with safe and healthy working conditions. It is a practical way of living out Paul's call for justice and dignity in the workplace.

#### Psalm 146 – God Lifts Up the Oppressed

Psalm 146 is a beautiful psalm of praise that reminds us of God's care for the vulnerable and oppressed:

"He upholds the cause of the oppressed and gives food to the hungry. The Lord sets prisoners free, the Lord gives sight to the blind, the Lord lifts up those who are bowed down."

This psalm calls us to praise God for His justice, His mercy, and His concern for those who are suffering. It reminds us that God is not distant or indifferent to the struggles of the oppressed—He is actively working on their behalf.

But it also challenges us. If God is the one who lifts up the oppressed, then we, as His followers, are called to do the same. We are called to stand with those who are bowed down by unjust working conditions, to advocate for their dignity and wellbeing, and to support initiatives like Fairtrade that protect workers from exploitation.

# **Reflection: Ensuring Fair Working Conditions**

So how can we ensure that the products we buy are made under fair working conditions? How does God call us to care for those who labour in difficult or dangerous environments?

First, we need to **educate ourselves**. Many of us are unaware of the conditions under which the goods we buy are produced. We may not realise that the low prices we enjoy are often made possible by the exploitation of workers in other parts of the world. By choosing to buy Fairtrade products, we can ensure that the people who make the things we use every day are treated fairly and given safe, healthy working conditions.

Second, we must **raise awareness** in our communities. As a church, we can commit to using only Fairtrade products in our events and gatherings. We can organise campaigns, discussions, or educational events to spread the word about the importance of ethical working conditions.

Finally, we must **pray for and support** businesses that prioritise the health and safety of their workers. When we support ethical companies, we are helping to create a world where every worker is treated with the dignity and respect they deserve.

# **Action: Commit to Ethical Consumption**

As we reflect on these biblical principles, let's commit to buying products from companies that prioritise the health and safety of their workers. By choosing Fairtrade, we are making a statement about the kind of world we want to live in—a world where everyone is treated fairly, where workers' rights are respected, and where people can work in environments that protect their health and dignity.

Consider hosting a Fairtrade awareness event in your church or community. Let's raise our voices for justice and create change through our choices.

# Sermon 8: Building Capacity – Empowering Through Fairtrade

#### Scriptures:

- 2 Chronicles 2
- Ephesians 4:14-16
- Proverbs 14:31

#### Introduction:

Good morning, Church. Today, we're going to reflect on **Principle 8 of Fairtrade – Capacity Building**. This principle focuses on helping producers build skills and improve their access to markets, enabling them to grow and prosper. It's about giving people the tools they need to create better futures for themselves and their communities.

But why is this important to us as Christians? The Bible speaks often of growth whether it's spiritual growth in our walk with God or practical growth in our work and relationships. God cares deeply about our development, both as individuals and as communities. In this sermon, we will explore how the principle of **capacity building** aligns with our faith and how we, as a church, can support the empowerment of disadvantaged producers around the world.

# 2 Chronicles 2 – Solomon Seeks Skilled Workers to Build the Temple

In 2 Chronicles 2, we find King Solomon preparing to build the temple, a monumental task that required skill and expertise. Solomon didn't build the temple on his own. He sought out skilled workers—people who were trained in craftsmanship, construction, and artistry. He recognised that the temple would be a reflection of God's glory and that it required the best efforts of skilled hands.

This story reminds us that **building something great requires the development of skills**. Solomon knew that the temple would be a place where God's presence would dwell, and so he invested in skilled workers to bring it to life.

In the same way, Fairtrade recognises that producers—whether they are farmers, artisans, or workers—need training and support to develop their skills and grow their businesses. Fairtrade provides access to education, market knowledge, and new technologies, allowing producers to improve their livelihoods and support their communities.

As Christians, we are called to support this kind of development. Just as Solomon sought out skilled workers to build the temple, we are called to empower people to build better futures for themselves. By supporting Fairtrade, we are investing in people's capacity to grow, thrive, and honour God with their work.

# Ephesians 4:14-16 – Growing to Maturity in Christ

In Ephesians 4:14-16, Paul speaks about growing to maturity in Christ: "Then we will no longer be infants, tossed back and forth by the waves, and blown here and there by every wind of teaching... Instead, speaking the truth in love, we will grow to become in every respect the mature body of him who is the head, that is, Christ."

Paul is encouraging the early church to grow in their understanding of the faith, to work together in unity, and to mature in their relationship with Christ. This idea of **growth and development** is central to the Christian life. We are not meant to remain stagnant in our faith; we are called to grow, to learn, and to become more like Christ.

This same principle applies to the idea of **capacity building** in Fairtrade. Producers are not meant to remain in cycles of poverty and exploitation. They are meant to grow, to develop their skills, and to achieve economic independence. Fairtrade helps producers to grow in their businesses, just as the church helps believers grow in their faith.

When we support Fairtrade, we are participating in this process of growth and development. We are helping people to gain the skills and knowledge they need to improve their lives, support their families, and contribute to their communities. In this way, we are living out our calling to be the body of Christ—working together to bring justice, mercy, and love to the world.

# Proverbs 14:31 – Kindness to the Needy Honours God

Proverbs 14:31 gives us a powerful reminder:

"Whoever oppresses the poor shows contempt for their Maker, but whoever is kind to the needy honours God."

This verse highlights a fundamental truth: how we treat the poor and vulnerable is a direct reflection of how we honour God. If we oppress the poor—whether through exploitation, indifference, or unfair trade practices—we are dishonouring the very One who created them.

But when we show **kindness**—when we support those in need, empower them, and work for their dignity and wellbeing—we honour God. Fairtrade is one way we can show this kindness in practical ways. By supporting Fairtrade products, we are ensuring that the people who grow our food and make our goods are treated with respect, paid fairly, and given the opportunity to improve their lives.

This is not just a matter of charity; it's a matter of justice. As Christians, we are called to do justice, love mercy, and walk humbly with our God (Micah 6:8). Supporting

capacity building through Fairtrade is one way we can live out this calling in a global context.

# **Reflection: How Can We Support Capacity Building?**

# Sermon 9: Promoting Fairtrade – A Call to Action for Justice

# Scriptures:

- Micah 3:8-12
- James 2:1-18
- Ezekiel 45:9-11

# Introduction:

Good morning, Church. Today we reflect on a topic that strikes at the very core of our Christian faith—justice. In our increasingly interconnected world, we can no longer ignore the injustices faced by those who produce the goods we consume every day. **Fairtrade** challenges us to consider how our faith calls us to act on behalf of the vulnerable and marginalised. Principle 9 of Fairtrade calls us to promote greater justice in world trade and to advocate for ethical business practices.

But why does this matter to us as Christians? Because at the heart of our faith is a God who is deeply concerned with justice, a God who calls us not just to believe in justice, but to **do justice**. In today's world, the leaders Micah speaks to are not only government officials or political figures, but **business leaders, corporations, and consumers**—people who have the power to shape the marketplace. We, too, are leaders in this sense. Every purchase we make is a moral choice, and every business we support reflects our values. Micah's call is for all of us to use our influence, however great or small, to promote justice.

# James 2:1-18 – Faith Without Works is Dead

In the New Testament, James reminds us that faith must lead to action: "What good is it, my brothers and sisters, if someone claims to have faith but has no deeds? Can such faith save them? Suppose a brother or sister is without clothes and daily food. If one of you says to them, 'Go in peace; keep warm and well fed,' but does nothing about their physical needs, what good is it?"

James is challenging us to reflect on what it means to **live out our faith**. It's not enough to pray for justice; we must also act on behalf of those who are suffering. When we buy products that are not ethically sourced, we may unknowingly contribute to systems of exploitation—poor wages, unsafe working conditions, child labour.

Fairtrade offers us a way to put our faith into action. By supporting Fairtrade products, we ensure that the people who grow our food and make our clothes are treated with dignity and paid fairly for their work. It's a small but powerful way to make our faith visible in the world.

# Ezekiel 45:9-11 – God's Call for Justice and the End of Exploitation

In Ezekiel 45:9-11, God commands the leaders of Israel to stop their exploitation: "This is what the Sovereign Lord says: 'You have gone far enough, princes of Israel! Give up your violence and oppression and do what is just and right. Stop dispossessing my people, declares the Sovereign Lord.'"

God calls for fair trade practices and justice in the marketplace. The passage talks about the use of fair weights and measures in trade—this is a reminder that **ethical business practices** are not a modern invention. God has always cared about fairness in trade and warned against exploiting others for personal gain.

This ancient call is still relevant today. Fairtrade promotes justice in the global economy by ensuring that workers are paid fairly and that producers are not exploited. It is one way we can help end modern-day exploitation and uphold the values of justice that God demands.

# **Reflection: How Can You Promote Fairtrade?**

So, how can we promote Fairtrade in our own lives, in our church, and in our community?

First, we must educate ourselves about the impact of our choices. Many of us may not realise that the products we buy, from coffee to chocolate to clothing, often come from supply chains riddled with exploitation and injustice. We can make a difference by choosing to buy Fairtrade products, which ensure that workers are paid fairly and work in safe conditions.

Next, we can encourage our church to support Fairtrade initiatives. Could we use only Fairtrade tea and coffee after services? Could we host an event to raise awareness about Fairtrade and its impact on vulnerable communities around the world? Small actions like these can have a big impact when we work together as a church.

Finally, we can share this message with our communities. Each of us can be an advocate for justice in the marketplace by telling others about Fairtrade and encouraging them to make more ethical choices.

# Action: Organise a Fairtrade Event or Stall

# Sermon 10: Respect for the Environment – Our Sacred Duty

#### Scriptures:

- Genesis 1:24-31
- Psalm 24:1
- Psalm 65:9-13

#### Introduction:

Good morning, everyone. Today, I want to speak about something that is at the very heart of our Christian faith but often overlooked in our daily lives—our responsibility to care for God's creation. As we reflect on Principle 10 of Fairtrade—**Respect for the Environment**—I believe we are being called to renew our understanding of stewardship. How we treat the world around us is not just an issue of ethics or politics, but an expression of our relationship with God.

We live in a time where environmental crises are becoming more apparent each day. The air we breathe, the water we drink, the land we live on—each is a gift from God. But with that gift comes a sacred responsibility, one that has been entrusted to humanity since the very beginning of creation.

# Genesis 1:24-31 – Humanity's Responsibility to Care for Creation:

In Genesis 1:24-31, we find the well-known creation story, where God creates all living creatures and finally creates humanity in His image. In verse 28, God gives Adam and Eve—and by extension, all of us—a divine mandate: "Be fruitful and increase in number; fill the earth and subdue it. Rule over the fish in the sea and the birds in the sky and over every living creature that moves on the ground."

Now, the word "subdue" might raise some eyebrows today. Does God mean that we should exploit the earth? Certainly not! The context of this command is not one of exploitation but of **stewardship**. God has placed us in a position of care over His creation. To "rule" over creation is to take responsibility for its flourishing, to ensure that the world remains as God intended—teeming with life, beauty, and balance.

But as we look around today, it's clear that humanity has not always been a faithful steward. Whether it's through pollution, deforestation, or the overuse of natural resources, we have fallen short in our responsibility to care for this earth. In ignoring our role as stewards, we neglect a part of our calling as people made in God's image.

# Psalm 24:1 – The Earth Belongs to the Lord:

Psalm 24:1 declares, "The earth is the Lord's, and everything in it, the world, and all who live in it."

This verse reminds us of a simple yet profound truth: **We do not own the earth.** The earth belongs to God. We are merely caretakers of His creation. This understanding should deeply affect how we interact with the world around us. The resources we use, the energy we consume, the products we buy—these are not ours to waste or exploit. They belong to God, and we are accountable for how we use them.

Too often, we fall into the trap of thinking that the earth's resources are infinite, that there will always be more to take. But Psalm 24 challenges us to see the world through God's eyes. Everything we see—the forests, the rivers, the wildlife—is sacred. It's not ours to manipulate or exhaust, but to cherish and protect.

# Psalm 65:9-13 – God's Provision for Creation:

Psalm 65:9-13 paints a beautiful picture of how God cares for His creation: "You care for the land and water it; you enrich it abundantly. The streams of God are filled with water to provide the people with grain, for so you have ordained it."

This psalm shows us how deeply God is involved in the ongoing care of His creation. God provides the rain that nourishes the earth, causing crops to grow and feeding all living things. Creation is not something static; it's alive, constantly nurtured by God's provision.

If God cares this much for creation, how much more should we? How can we claim to love God, yet neglect or harm the very world He sustains? The environment is not just a backdrop to our lives; it's a part of God's ongoing story of creation and redemption.

#### **Reflection: Caring for the Environment and Our Relationship with God:**

So how does caring for the environment reflect our relationship with God? Quite simply, it's an act of worship. When we care for creation, we are honouring the Creator. When we choose to live sustainably, we are aligning our hearts with God's will for the world. We are called to mirror God's love for the world, and that includes loving the earth.

Every choice we make—from the food we eat to the energy we use—reflects our understanding of stewardship. Are we consuming mindlessly, thinking only of convenience? Or are we living thoughtfully, recognising that our actions have consequences for God's creation and for future generations?

Caring for the environment is not just about being a "good person" or "doing the right thing." It's about embodying our faith in tangible ways. It's about living out the command to love our neighbour, for environmental degradation often affects the

most vulnerable among us—those who are least able to recover from floods, droughts, or food shortages.

# Action: What Can We Do?

So, what can we do to reflect our care for God's creation? The Fairtrade movement offers one practical way we can make a difference. By choosing Fairtrade products, we not only support ethical treatment of workers but also ensure that the environment is cared for in the process. Many Fairtrade products are produced using sustainable practices that honour the earth's resources.

But we can do more:

- **Reduce your environmental footprint**: Consider how you can use less energy, reduce waste, and consume responsibly. Small actions like reducing plastic use or switching to renewable energy can have a big impact.
- Encourage your church to adopt sustainable practices: Could your church switch to Fairtrade tea and coffee? Could you start a recycling initiative or reduce energy consumption in the church building?
- **Support eco-friendly businesses**: When we choose to buy from businesses that prioritise sustainability, we are using our purchasing power to protect the planet. We are supporting practices that align with God's heart for creation.
