

Planning

Internal Fundraising

- Use Church reserves, congregation gifts, <u>Diocese grants</u>, conversations with local council and trusts.
- Aim for 50% of total cost
- If you find that you are a long way short of this, consider if there is a way your project could be phased

Permissions

 Get Local Authority (or National Park if applicable) Planning Permission and <u>Faculty</u> permissions in place





Grants to Reduce Isolation and Loneliness Among Older People Across Great Britain

27/03/2025

Barchester Healthcare Foundation is offering grants of up to £2,500 for small community groups and local charities across England, Scotland, and Wales for projects that help reduce isolation and loneliness, promote group activities, and generally improve mobility and quality of life for older people and adults with physical, learning, or mental disabilities.

Funding is intended to help small community groups and local charities with the following:

- Activities.
- Equipment and materials for use by members.
- Member transport.
- Day trips, outings, and group holidays in the UK.

Priority will be given to innovative projects that help older people and those with a disability to get active, meet people, and reduce isolation.

Funding is for small and local groups, and groups with financial reserves of over £150,000 are unlikely to receive support.

Applications can be submitted at any time.



ENERGY FOOTPRINT TOOL (EFT)

- ✓ The EFT is an online tool to help you reveal your carbon footprint based on energy used to heat and light your church buildings
- ✓ Access to the EFT is on the Parish Returns website. Completion alongside the Return of Parish Finance (RoPF) is recommended.
- ✓ EFT completion is essential to be considered for National Church funding e.g. Net Zero Carbon Grants.
- √ 68% of parishes in Diocese completed the EFT in 2023.



Q1. How can we encourage more churches to complete the Energy Footprint Tool (EFT)?

- A. First of all we need to make sure that we know who in our PCC team is completing the EFT. It could be the treasurer, the churchwarden, the "energy person" on our team and each might think the other is completing the EFT!
- B. We need churches to understand what the benefits are to completing the EFT. One benefit of completing the EFT is that it enables you to fulfil the criteria for applying for National church grants however that could also mean many churches don't actually think about completing the EFT until they actually need a grant.
- C. The EFT form is also quite difficult to complete e.g. for a church with an attached hall the EFT form doesn't really fit. For example, it's difficult to complete for a church with a number of halls attached and one heating system throughout. The church itself may not be used but the halls are used constantly. How can we use the EFT to reflect that? Can the form be made easier?

The above answers were comments received from treasurers who discussed the question in the Breakout session.



Q2. Why are there very few Green Suppliers on the dropdown list on the EFT that we haven't heard of before?

A. The Church of England are currently doing some work nationally around what a green tariff is and are planning to communicate this later in the summer. For now, please just fill in the EFT using the small number from the list – all will be clearer when this information is out.

Q3. Who has responsibility for filling in the EFT?

A. The PCC. It is recommended that the PCC nominate a person to do the job, but it is not a designated role from the Diocese or CofE.

Q4. How do I fill it in if my buildings and heating systems are linked together? Do I fill it in for my Church Hall?

A. You fill out the form for each building you manage, whether it is a Church, a Church Hall or a combined building. If you have 2 buildings linked with one supply, it is best to fill this as one building. If they have separate supplies, fill it out twice. This best thing to do is be consistent on your approach year on year.

You can find out if a building is 'in scope' by using the **Building Scope Checker Tool**

Q5. How accurate do we need to be with figures when you have credits and disputes? We have credit notes in 2025 for 2024 bills, so both years will be wrong if I use the bills. What should I do?

A: Ideally, if you can, subtract the credit note usage from your 2024 total to give us the usage for that year as accurately as you can, even though it won't match the bills. If not, just fill it in as per your bills and make a note on the form. This is not a test and we won't ask to see all your bills to check the numbers, so please don't worry if your approach doesn't match the numbers on your paperwork - just make a note so you don't double count (or not include them) next year!

Q6. What is the impact of we get it wrong? Will we be held to account if we make mistakes or don't give accurate numbers?

A: In order for you to calculate your Parish's Carbon Footprint accurately, it is, of course, important that the numbers are correct. However, this is not a test, and we will not be asking for proof of the numbers you put in. So your 'best work' will suffice. Just make a note of any approximations or special cases you have had to make when you fill in the form.



Q7. Are we charged the climate change levy as Charities?

A: No. Charites are exempt from the climate change levy. Full details from HMRC here

Q8. I cannot see the purpose of supplying this information to the diocese. Is it going to make any difference whatsoever to the challenge of global warming?

A: It's for monitoring both at a Parish level and nationally. As a Church, we all have a responsibility to care for God's creation and we cannot do that effectivly without knowing the impact we are having on the climate. The EFT will help you see your Parish's impact and allow you a starting point to measure your reduction.

Nationally, the CofE want this data to allow for the delivery of further funding into the Environment programme. The CofE has the (ambitious) target nationally to be at Net Zero by 2030 and they need to monitor how Churches are doing. If every church is already at Net Zero and has no carbon footprint, then the Church of England doesn't need to release further money/support for getting there!



Q9. The EFT shows Carbon Emissions (Tonnes) for 2024. Will it become zero Tonnes when you've reached Net Zero Carbon? Has any Treasurer got an EFT with 0 Tonnes? A: That's the aim! I don't know of any Churches in that position, but if you have solar, batteries and electric heating, it could be possible.

Q10. Should our gas invoices say how much CO2 emissions we've done? What's the equation from kWh?

A: The short answer is that it is complicated! The conversion from kWh to TCO2 depends on the grid's conversion factor which can change as the carbon footprint of a kWh of gas is not static. This is especially true of electricity as the grid decarbonises (but is susceptible to weather changes). That is why the EFT only asks for usage – the CofE uses consultants to calculate the carbon footprint of the estate and produce comparable year-on-year figures which consider weather patterns and the grid's decarbonisation rate – things which are not in our control.
